



A new Human Rights Watch <u>report</u> finds that authorities in the United Arab Emirates have arbitrarily detained between 2,400 and 2,700 Afghans for over 15 months in the "Emirates Humanitarian City," a humanitarian logistics hub in Abu Dhabi.

Detainees reported constraints on their freedom of movement, poor living conditions, lack of access to legal counsel, no psychosocial support, and lack of access to fair and effective refugee status determination and safe and legal pathways for onward movement.

Human Rights Watch is calling on the US government to leverage its influence with the UAE to urge them to release detained Afghan evacuees and to urgently expedite the processing of pending US asylum, humanitarian parole, or other visa applications by Afghans in the UAE.
